TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed the above noted Zoning By-law, under Section 34 of the Planning Act, R.S.O., 1990, c.P.13. There were no written and oral submissions from the public on this matter. This notice is issued in accordance with Ontario Regulation 345/20 under the Emergency Management and Civil Protection Act.

THE PURPOSE AND EFFECT of this By-law is to temporarily permit outdoor patios accessory to restaurants, convenience restaurants and take-out restaurants in certain Base and Exception Zones within the City of Mississauga limits, until December 31, 2020.

A by-law to amend By-law Number 0225-2007, as amended.

WHEREAS pursuant to section 39 of the *Planning Act*, R.S.O. 1990, c.P.13, as amended, the council of a local municipality may in a zoning by-law passed under section 34 of the *Planning Act*, authorize the temporary use of land, buildings or structures for such purpose as set out therein, limited to a period of time not exceeding three years;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

- 1. By-law Number 0225-2007, as amended, being a City of Mississauga Zoning By-law, is amended by adding Article 1.1.13.3 to Subsection 1.1.13 as follows:
 - 1.1.13.3 Notwithstanding the provisions of Articles 1.1.13.1 and 1.1.13.2, a Certificate of Occupancy shall not be required for a **temporary outdoor patio**.
- 2. By-law Number 0225-2007, as amended, is further amended by adding the following Definition to Section 1.2:

Temporary Outdoor Patio	means an accessory seating area, located adjacent to or within proximity of a restaurant, convenience restaurant or take-out restaurant.

3. By-law Number 0225-2007, as amended, is further amended by adding Article 2.1.9.14 to Subsection 2.1.9 as follows:

2.1.9.14 Temporary Outdoor Patio

In addition to the provisions contained in Parts 1 and 2 of this By-law, a **temporary outdoor patio** shall comply with the provisions contained in Table 2.1.9.14 - Temporary Outdoor Patio.

- 4. By-law Number 0225-2007, as amended, is further amended by adding Sentence 2.1.9.14.1 to Article 2.1.9.14 as follows:
 - 2.1.9.14.1 The provisions contained in Article 1.1.13.3, Section 1.2 (only temporary outdoor patio) and Article 2.1.9.14 of this By-law shall only be in effect for a temporary period from the date of enactment and passing of a temporary use by-law until December 31, 2020.
