**TAKE NOTICE** that the Council of the Corporation of the City of Mississauga passed the above noted Zoning By-law, under Section 34 of the Planning Act, R.S.O., 1990, c.P.13. There were no written and oral submissions from the public on this matter. This notice is issued in accordance with Ontario Regulation 345/20 under the Emergency Management and Civil Protection Act.

**THE PURPOSE AND EFFECT** of this By-law is to permit an extension of the permission for temporary outdoor patios accessory to restaurants, convenience restaurants and take-out restaurants in certain Base and Exception Zones, until December 31, 2021. This By-law also amends the definition of temporary outdoor patios to permit temporary tents over the patios.

A by-law to amend By-law Number 0225-2007, as amended.

WHEREAS pursuant to section 39 of the *Planning Act*, R.S.O. 1990, c.P.13, as amended, the council of a local municipality may in a zoning by-law passed under section 34 of the *Planning Act*, authorize the temporary use of land, buildings or structures for such purpose as set out therein, limited to a period of time not exceeding three years;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. By-law Number 0225-2007, as amended, being a City of Mississauga Zoning By-law, is amended by adding the words ", that may be covered by a temporary tent" to the definition of "**Temporary Outdoor Patio**" in Section 1.2 as follows:

Temporary means an accessory seating area, located adjacent to or within proximity of a restaurant, convenience restaurant or take-out restaurant, that may be covered by a temporary tent. (0163-2020)

- 2. By-law Number 0225-2007, as amended, is further amended by changing the date in Sentence 2.1.9.14.1 contained in Article 2.1.9.14 as follows:
  - 2.1.9.14.1 The provisions contained in Article 1.1.13.3, Section 1.2 (only temporary outdoor patio) and Article 2.1.9.14 of this By-law shall only be in effect for a temporary period from the date of enactment and passing of a temporary use by-law until December 31, 2020. December 31, 2021. (0163-2020)
