BY-LAW NUMBER 0100-2024

A by-law to amend By-law Number 0225-2007, as amended.

WHEREAS pursuant to section 34 of the *Planning Act*, R.S.O. 1990, c.P.13, as amended, the council of a local municipality may pass a zoning by-law;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. By-law Number 0225-2007, as amended, being a City of Mississauga Zoning By-law, is amended by adding the base zone "C3" to Cell B1.0 and adding Note (2) to Table 2.1.9.14 contained in Subsection 2.1.9 as follows:

1.0	A seasonal outdoor patio is permitted accessory to a restaurant, convenience restaurant or take-out restaurant only in these zones	O1 to O3, C1, C2, C3, C4, H-CC1 to H-CC4, CC1 to CC4, H-CCO, CCO and E1 to E3 zones ⁽¹⁾⁽²⁾

2. By-law Number 0225-2007, as amended, is further amended by adding Sentence 2.1.9.14.2 to Article 2.1.9.14 as follows:

2.1.9.14.2 Notwithstanding Line 1.0 contained in Table 2.1.9.14 of this By-law, minor variance decision 'A' 303/20, or any temporary use by-law, a **seasonal outdoor patio** shall not be permitted on lands identified on Schedule 2.1.9.14(4) of this By-law, after the date of enactment and passing of this By-law (May 29, 2024).

3. By-law Number 0225-2007, as amended, is further amended by adding Schedule 2.1.9.14(4) to Article 2.1.9.14 as attached to this By-law.

4. By-law Number 0225-2007, as amended, is further amended by adding the base zone "C3" to Cell B1.0 and adding Note (2) to Table 2.1.9.16 contained in Subsection 2.1.9 as follows:

2.1.9.16.2 Notwithstanding Line 1.0 contained in Table 2.1.9.16 of this By-law, minor variance decision 'A' 303/20, or any temporary use by-law, a permanent outdoor patio shall not be permitted on lands identified on Schedule 2.1.9.14(4) of this By-law, after the date of enactment and passing of this By-law (May 29, 2024).

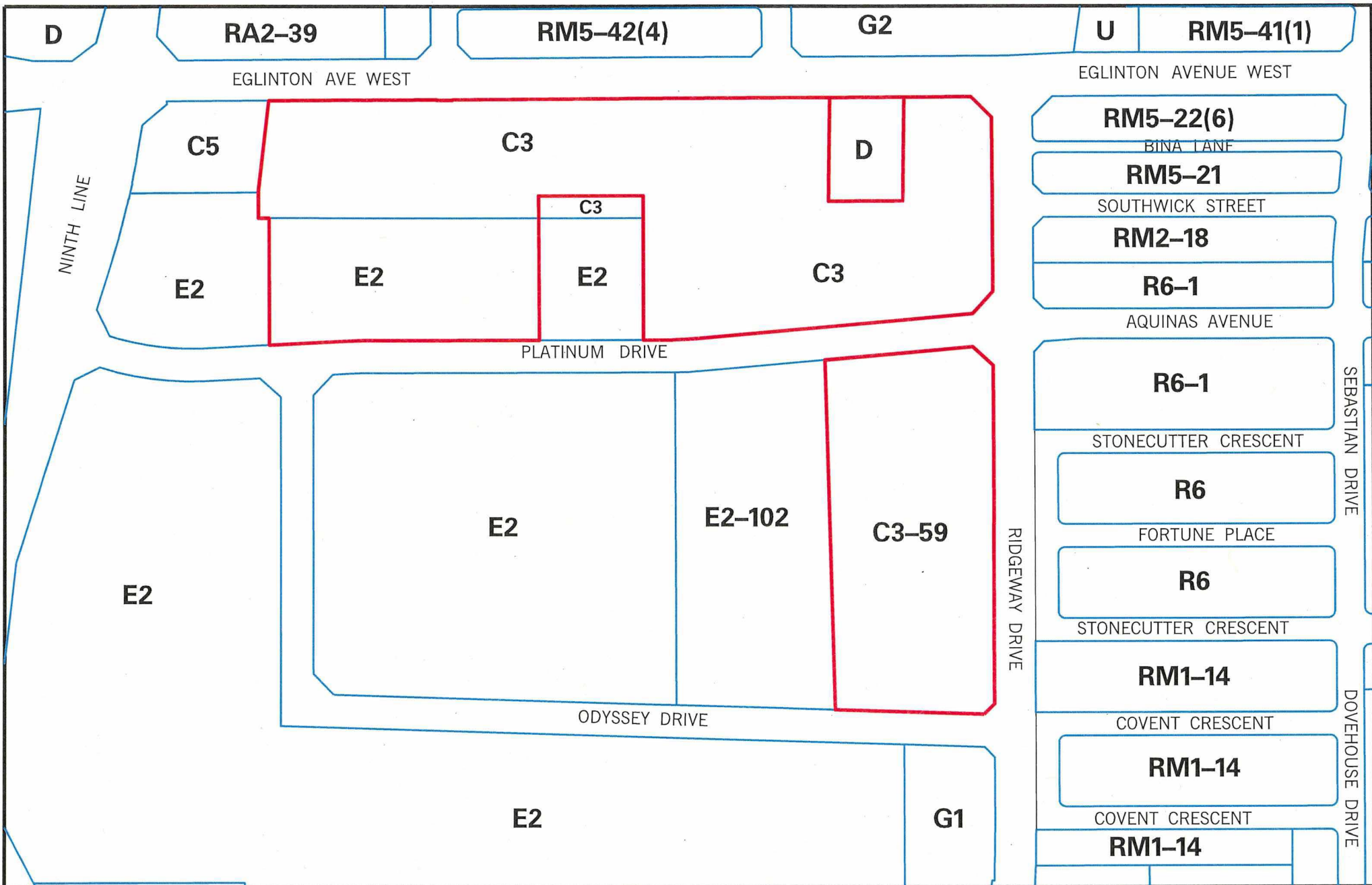
