#### **Information about Appeals:**

Only a registered owner of land affected by the by-law and official plan amendment, a specified person or a public body, and the Minister of Municipal Affairs and Housing is entitled to appeal. If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed and official plan amendment is adopted, the person or public body is not entitled to appeal the decision of City Council to the Ontario Land Tribunal, or be added as a party to an appeal of the decision to the Tribunal.
