The Cycling Equity, Diversity and Inclusion (EDI) Recognition Award is presented by the Mississauga Cycling Advisory Committee, or a representative thereof, to a person or persons who have demonstrated EDI while promoting cycling or other forms of sustainable transportation through implementation of specific programs or initiatives to improve access to related resources, events, etc., for marginalized (i.e., people with disabilities, low-income households) and other, underrepresented communities in the City of Mississauga over the preceding year.

Completed nominations can be mailed to cycling@mississauga.ca or sent via email using the SUBMIT button below. The SUBMIT button will open an email with the completed form attached. Supporting documentation should be added at that time.

Eligibility

Mississauga resident(s) of any age are eligible for the Cycling EDI Recognition Award provided that:

1. They or any member of their immediate family are not a current member of, or have not been a member of MCAC for a minimum of a full term of Council.
2. They or any member of their immediate family are not employed with the City of Mississauga or the Region of Peel in any capacity related to cycling or sustainable transportation.
3. They have not been awarded the Cycling Equity, Diversity and Inclusion Recognition Award within the last four years.

Nomination Process

Nominations may be made through a written recommendation outlining the reasons why the nominee is worthy of the Cycling EDI Recognition Award and submitted to the Mississauga Cycling Advisory Committee. Self-nominations are permitted.

Selection Process

Nominations can be submitted to the Mississauga Cycling Advisory Committee any time during the year; however a nomination deadline may be set annually for that year's selection process. The Communications and Promotions Subcommittee will review the nominations, and the Subcommittee will present the proposed recipient to the Mississauga Cycling Advisory Committee in Closed Session. The recipient will be selected by the majority vote of the Mississauga Cycling Advisory Committee during the first three months of the year, for the preceding year, and the award will be presented by Mississauga City Council, or a representative thereof, as soon as practical after the selection has been made.

Note: the Mississauga Cycling Advisory Committee's Communications and Promotions Subcommittee reviews all nominations, but reserves the right not to issue an award if a suitable candidate cannot be found.
