


## CITY OF MISSISSAUGA 1 PORT STREET EAST PROPOSED MARINA ENVIRONMENTAL ASSESSMENT NOTICE OF SUBMISSION ENVIRONMENTAL ASSESSMENT

The City of Mississauga has undertaken the 1 Port Street East Proposed Marina environmental assessment (EA) as required under the *Environmental Assessment Act* and according to the Terms of Reference approved by the Minister of Environment Conservation and Parks on September 16, 2021. The City of Mississauga has submitted its environmental assessment to the Ministry of the Environment Conservation and Parks for review and approval.

The EA considered the benefits and effects of the range of design alternatives for the proposed marina and waterfront parkland along the eastern side of the Port Credit Harbour marina basin on the eastern side of the mouth of the Credit River in the City of Mississauga.

As required under the *Environmental Assessment Act*, the environmental assessment will be available for public review and comment from October 18, 2024, to December 6, 2024 for a seven week review period.
