

## II. Original Approvals

---

Mississauga Official Plan (MOP) was adopted by City Council on September 29, 2010 and partially approved by the Region of Peel on September 22, 2011 (subsequently there were 19 appeals to MOP, referred to as “Original Appeals”). MOP came into partial effect on November 14, 2012, when the Ontario Municipal Board (OMB) approved MOP with some modifications and except for those policies still under appeal.

Since the November 14, 2012 Decision, there have been further Decisions that have addressed the Region’s non-decision items and resolved several of the appeals to MOP, including the following:
