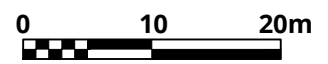




LEGEND:

- NOTES:**
1. RESIDENTS TO BE RESPONSIBLE FOR TRANSPORTING WASTE MATERIALS TO THE DESIGNATED WASTE CHUTE AS REQUIRED.
 2. PROPERTY MANAGEMENT TO BE RESPONSIBLE FOR MONITORING AVAILABLE CAPACITY WITHIN THE RESPECTIVE FRONT-END BINS, AND REPLACING FULL BINS WITH EMPTY BINS AS REQUIRED.
 3. PROPERTY MANAGEMENT TO BE RESPONSIBLE FOR JOCKEYING FRONT-END BINS FROM THE GARBAGE ROOMS TO THE DESIGNATED STAGING AND COLLECTION AREAS ON COLLECTION DAY.
 4. FRONT-END BINS TO BE PROPERLY POSITIONED IN THE COLLECTION AREA ON THE DAY OF COLLECTION BEFORE 7 AM.
 5. THE DRIVER IS NOT REQUIRED TO EXIT THE COLLECTION VEHICLE TO FACILITATE COLLECTION.
 6. PROPERTY MANAGEMENT IS RESPONSIBLE FOR MOVING FRONT-END BINS DURING COLLECTION.
 7. THE REGION WILL NOT BE RESPONSIBLE FOR EMPTYING BINS THAT ARE INACCESSIBLE TO THE COLLECTION VEHICLE.
 8. PROPERTY MANAGEMENT MUST BE VISIBLE TO THE WASTE COLLECTION VEHICLE ON APPROACH TO THE SITE, OTHERWISE THE WASTE COLLECTION VEHICLE WILL NOT ENTER THE SITE.
 9. PROPERTY MANAGEMENT WILL BE RESPONSIBLE FOR SAFELY MANEUVERING WASTE COLLECTION VEHICLES INTO AND/OR OUT OF, AS WELL AS AROUND THE SITE.
 10. PROPERTY MANAGEMENT STAFF WILL BE RESPONSIBLE FOR MOVING BINS TO THE STAGING AREA AT THE TIME OF COLLECTION AND RETURNING TO THE STORAGE ROOM FOLLOWING COLLECTION.
 11. MIXED WASTE TO BE COLLECTED BI-WEEKLY. RECYCLING TO BE COLLECTED WEEKLY.
 12. PROPERTY MANAGEMENT TO BE RESPONSIBLE FOR TRANSPORTING BULKY ITEMS TO THE DESIGNATED STAGING AREAS WITHIN THE GARBAGE ROOMS AS REQUIRED.
 13. PROPERTY MANAGEMENT TO BE RESPONSIBLE FOR TRANSPORTING BULKY ITEMS FROM THE STAGING AREAS TO THE DESIGNATED COLLECTION AREAS ON COLLECTION DAY.
 14. BULKY ITEMS TO BE COLLECTED ON THE SAME DAY AS GARBAGE-ONLY COLLECTION, SUCH THAT SUFFICIENT SPACE IS AVAILABLE WITHIN THE COLLECTION AREAS.
 15. PROPERTY MANAGEMENT TO BE RESPONSIBLE FOR TRANSFER OF RETAIL WASTE MATERIALS TO THE DESIGNATED STORAGE ROOMS.
 16. ALL DOORS IN WASTE STORAGE/STAGING/COLLECTION AREAS TO BE 2.5 m WIDE MIN.
 17. RETAIL WASTE MATERIALS ARE TO BE COLLECTED BY A PRIVATE WASTE COLLECTION CONTRACTOR.
