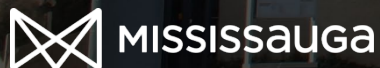

## Highlights

The Living Arts Centre is a 225,000 square foot multi-purpose venue boasting with three theatres, studio and art spaces, meeting rooms, and a glass artwork piece, the *Dance of Venues by Stuart Reid*, in the Atrium.

The *Main Auditorium (formerly Hammerson Hall)*, is just over 1,300 seats, one of the largest stages in Ontario, with no seat further than 125 feet from the stage, providing an intimate and professional quality experience.

*Studio Theatre (formerly RBC Theatre)* has a capacity of up to 310 guests, with the option of 360-degree seating on upper balconies, and customizable tiered seating.

*Screening Room (formerly Rogers Theatre)* is a newly renovated full functioning cinema space, perfect for breakout rooms, presentations, and film screenings, with a capacity for 110.

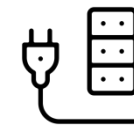

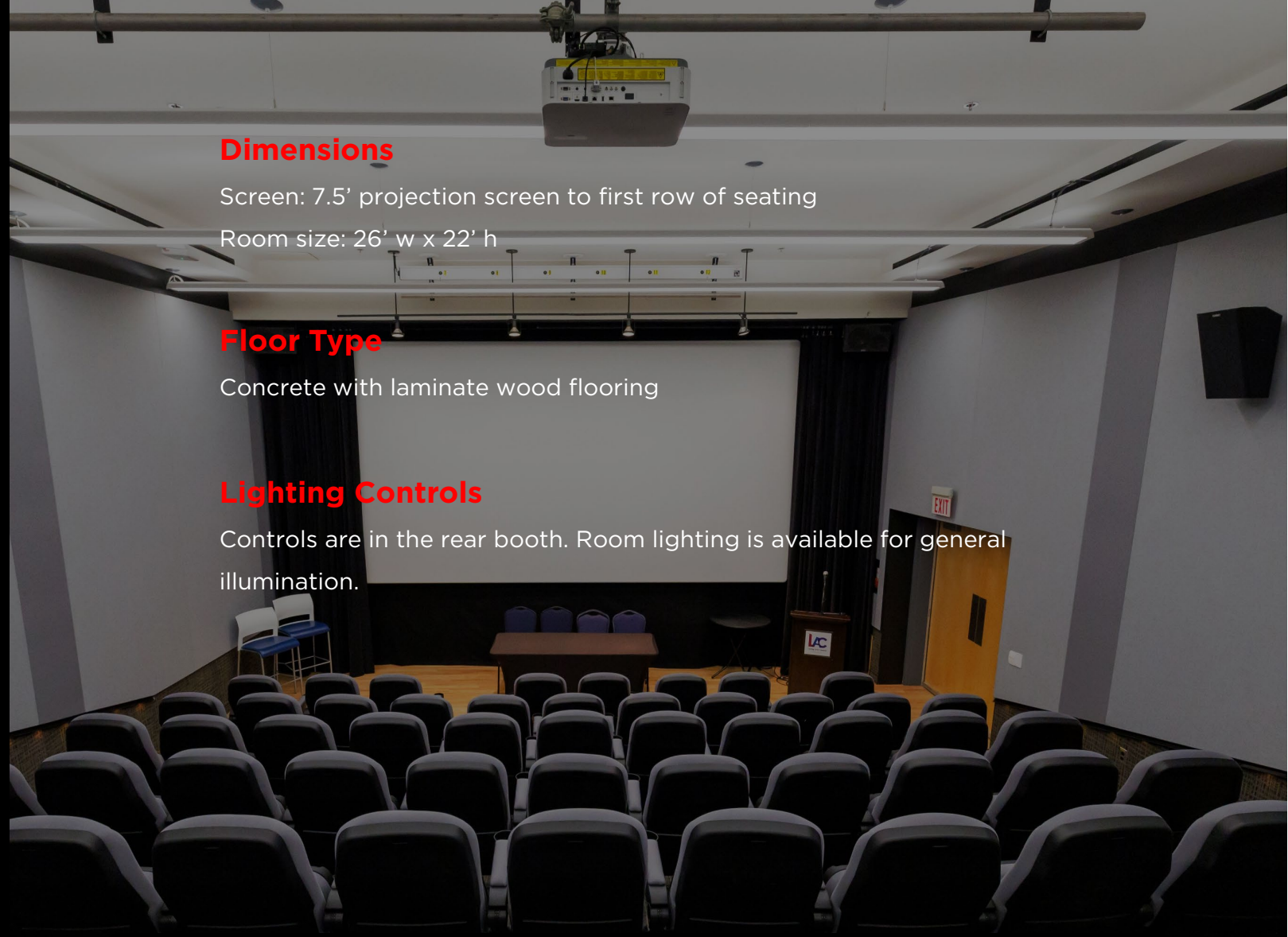

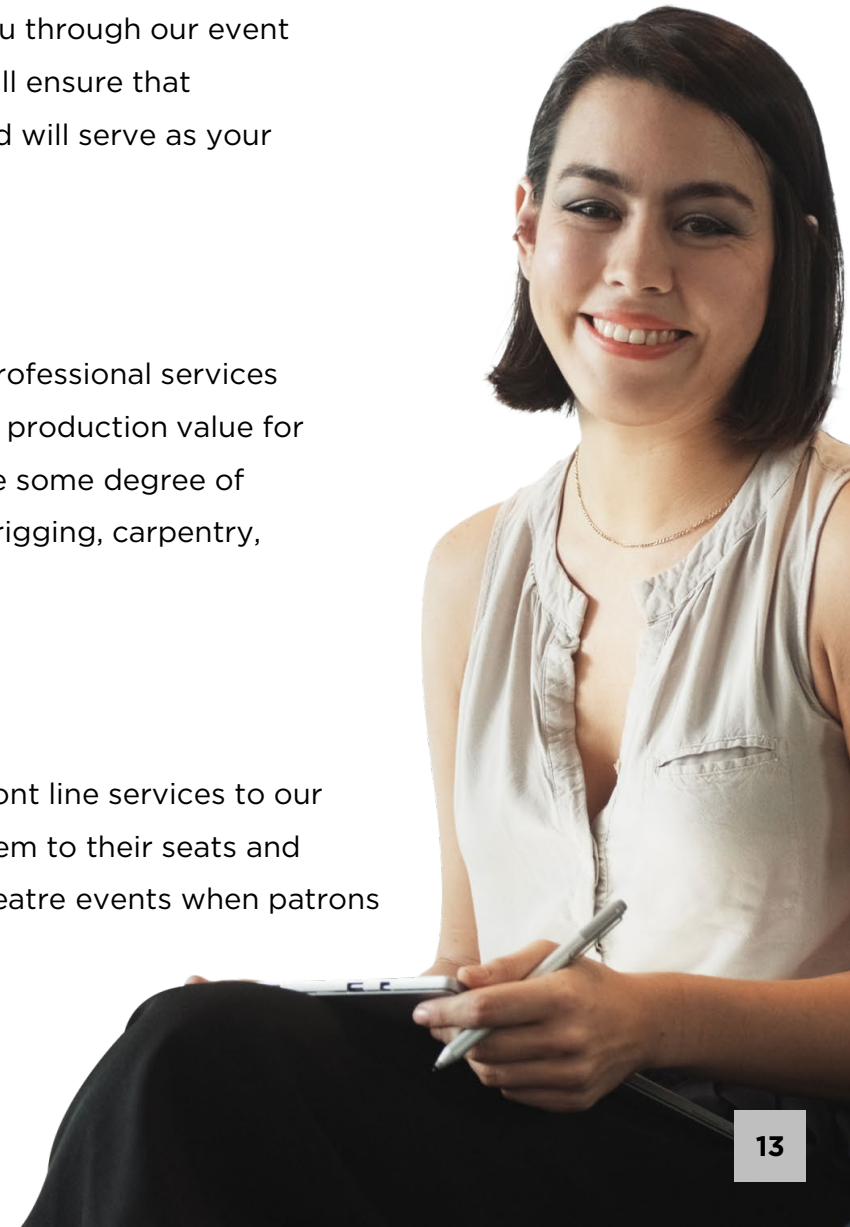

## Deposit Requirements & Contract Execution

All arrangements for rentals are tentative until a contract has been signed and payment of the Facility Rental Fee has been received.

### Ticketed Events (one (1) day rental):

- Full payment of the Facility Rental Fee (non-refundable) is due at the time of booking.
- A secondary payment of 50% of the estimated Event Fees is due 45 calendar days prior to the event; payment may be made in full or in part from ticket sales revenues.
  - If ticket sale revenue is insufficient to cover the secondary payment, a pre-authorized payment or post-dated cheque for the balance of estimated Event Fees is required at that time.
- The balance of the estimated Event Fees is due ten (10) calendar days prior to the event; payment may be made in full or in part from ticket sales revenues.
  - Payments made by cheque less than 14 days prior to an event must be by certified cheque.
- Payment of any additional charges incurred during or after the event date is due within 30 calendar days after receipt of the final invoice.

## Deposit Requirements & Contract Execution

All arrangements for rentals are tentative until a contract has been signed and payment of the Facility Rental Fee has been received.

### Ticketed Events (Two (2) or more consecutive rental days):

- A (non-refundable) deposit of the first two (2) days of Rental Fees is due at the time of booking.
- A secondary payment of 50% of the estimated Event Fees and the balance of the Rental Fees is due 45 calendar days prior to the start of the event; payment may be made in full or in part from ticket sales revenues.
  - If ticket sales revenue is insufficient to cover the secondary payment, a pre-authorized payment or a post-dated cheque for the balance of estimated Event Fees is required at this time.
- The balance of estimated Event Fees is due ten (10) calendar days prior to event; payment may be made in full or in part from ticket sales revenues.
  - Payments made by cheques less than 14 days prior to an event must be by certified cheque.
- Payment of any additional charges incurred during or after the event date is due within 30 calendar days after receipt of the final invoice.

## Deposit Requirements & Contract Execution

All arrangements for rentals are tentative until a contract has been signed and payment of the Facility Rental Fee has been received.

### Non-Ticketed Events:


- Full payment of the non-refundable Facility Rental Fee and pre-authorized payment or postdated cheques for 100% of estimated Event Fees is due at the time of booking.
  - A booking is only confirmed upon the receipt of both the Rental Fee and pre-authorized payment or post-dated cheques for estimated Event Fees.
- 25% of the estimated Event Fees is due 60 calendar days prior to the event.
- The balance of estimated Event Fees is due 30 calendar days prior to the event.
- Payment of any additional charges incurred during or after the event date is due within 30 calendar days after receipt of the final invoice.

## Insurance Requirements

General liability insurance is required for all events at Living Arts Centre. The following insurance requirements must be met for all events at the Square:

- \$5 million general liability insurance
- Name “The Corporation of the City of Mississauga” as an additional insured
- Cover all event dates including set-up and clean-up
- Proof of Insurance will only be accepted on the **City of Mississauga template**
- Must be signed, dated, and stamped by the insurance provider or broker

# Ticket Office and Sales

All ticket services pertaining to the event are performed through our Ticket Office, exclusively by Ticketmaster Canada. The Ticket Office will act as treasurer for all event revenue and will be responsible to the promoter for accurate accounting of all admission rights. Revenue cannot be released to the promoter prior to the execution of the event, in case of a cancellation where ticket refunds are necessary. The cost of the above service will be factored into your rental and expense agreement.

## Ticketmaster

The Promoter understands that the Living Arts Centre uses Ticketmaster as their ticketing platform for all attractions hosted in the Main Auditorium, the Studio Theatre, and the Screening Room. Ticketmaster's services are limited to serving as its agent for the sale and distribution of tickets. The Promoter is solely responsible for the marketing and promotion and the success of the Attractions. Ticketmaster makes no guarantee of the number of tickets that will be sold through the TM System for the Attractions. Further, Ticketmaster does not warrant that the use of the TM System will be uninterrupted or error free and it shall not be responsible for such interruptions or errors.

## Facility Fees

A \$2.55 Capital Refurbishment Fee plus a \$0.75 Single Ticket Processing Fee will be added to each ticket purchased for Attractions at Living Arts Centre, on all ticket purchasing channels including the Ticket Office. The Promoter will be required to advise if the fee will be deferred to the Ticket Purchaser at the time of purchase or added to the final settlement of the Promotor as an additional expense line. Additionally, all complimentary tickets pulled by the Promoter will be charged both fees and added to the final settlement as an additional expense line.


\* Ticket sale monies may be applied towards outstanding balance owing.

# Ticket Office and Sales

## Complimentary Tickets

Complimentary Tickets cannot exceed 250 tickets per Attraction and must be agreed upon by both the promoter and the Living Arts Centre. The Facility Fee will be charged on all Complimentary tickets and applied to the final settlement. Tickets cannot be sold for anything other than the face value, as per provincial law. Should the Licensee be found; exchanging tickets for money, at a value other than the zero-dollar face value, a penalty of \$1,000.00 will be applied to the final settlement.

## Postponement / Major Changes

When a Promoter makes a major change to an event, date/time change, patrons may request a refund and as per Ticketmaster Agreements, a refund will be granted, regardless of what the Promoter is offering. If an Attraction is postponed, the same rules apply as stated above. Please note, that tickets to the original Attraction date/time will be valid for the new Attraction date/time. No new tickets will be resent via Account Manager, Ticketmaster.ca, or email address, patrons will be asked to keep their original emailed tickets.

## Evacuation & Emergency Procedures

Living Arts Centre has established evacuation procedures for emergency situations. Our emergency plan promotes safety awareness and shows a commitment to the safety of workers and the public along with understanding the risks and hazards they may encounter and how to respond timely and appropriately. All Living Arts Centre staff are trained to deal with such situations. In the event of an evacuation, we request full participation and assistance to ensure the safety of everyone.

## Emergency Care and First Aid

The Living Arts Centre has fully stocked first aid kits throughout the facility and a First Aid room located on the ground level Galleria by the washrooms. The Centre is equipped with 2 AED units found in the atrium on the ground floor across from the Ticket Office, and on the 3rd floor by the elevator. We also have two wheelchairs available on site for transporting purposes.

## Smoking Policy

## Alcohol Management

The Living Arts Centre is compliant with all requirements set out and governed by the Alcohol and Gaming Commission of Ontario (AGCO). The AGCO is responsible for administering the Liquor License Act (LLA) and specific sections of the Liquor Control Act (LCA), which together with the regulations made under them establish the licensing and regulatory regime for most aspects relating to the sale and service of alcohol in Ontario. The consumption of alcoholic beverages must be strictly confined to designated areas. The sale of alcohol for any event is at the discretion of the Living Arts Centre.

City of Mississauga staff are trained to enforce the Alcohol Management Policy designed to:

- Ensure our guests have a safe and enjoyable experience
- Encourage guests who consume alcohol to do so in moderation and to not drink and drive
- Ensure staff is trained to serve alcohol responsibly and deal with guests in an appropriate manner

## Security Plans and Crowd Management

Event organizers must ensure that all participants and patrons are adequately safeguarded. Final event staffing levels and component parts of the overall event security plan will be solely at the discretion of the Living Arts Centre Staff.

The Living Arts Centre partners with a professional third-party security provider. Our team will determine the level of security staffing required for your event with all costs being the responsibility of the client.

During the run of the event certain precautions will be taken in advance to help reduce or eliminate unnecessary problems. The following is recommended:

- Advise of any VIPs which may attract attention.
- Disclosure of any problems you have experienced in the past with your event which may be prevented with advance planning.
- A comprehensive list of staff, crew, volunteers, and exhibitors/sponsors should be provided to the Event Coordinator, with a visible pass/credential system in place.
